

As implementation partner for RACC's The Right Brain Initiative since 2008, Young Audiences supports coordination of integrated arts programming in schools and management of teaching artists. This collaborative program unites teachers and teaching artists to create impactful arts experiences for students.

Arts for Learning

Young Audiences' arts integrated literacy curriculum helps students develop essential reading and writing skills. In partnership with the Beaverton School District and a 2010-15 Investing in Innovation (i3) project grant, Young Audiences' Arts for Learning Lessons will reach 30,000 3rd-5th graders.
